Research into online problem gambling says withdrawals should be faster and easier

London, 6 November: New research, funded by GambleAware, suggests how features of online gambling can contribute to problem gambling and provides new ideas to reduce harm. The report, by Dr Jonathan Parke, Sophro Ltd and Dr Adrian Parke, University of Lincoln, explains how remote gambling provides unlimited access to vast opportunities to gamble at any time and bet continuously. Moving online means sports betting is no longer immune to fast, continuous gambling, usually associated with casino games and slots. Problem gamblers in the study played at unsociable hours, through the night, logged in repeatedly to gamble during the day and could lose substantial amounts of money in short periods of time.

Research has focused on how problem gamblers chase loses. This report looked at the way winning influenced problem gamblers. It found risky gambling can escalate if problem gamblers fail to stop gambling shortly after winning, as their belief in their own luck or skill increases and they want positive feelings to continue. This risk is added to because it is easy to instantly re-deposit funds to chase loses, but much harder and slower to withdraw winnings, options are provided to reverse withdrawals and marketing prompts encourage further play.

Codes of practice for safe gambling should require that gambling operators should not nudge vulnerable customers to redeposit (e.g., by offering a deposit bonus) immediately after an account withdrawal. The research suggests withdrawals should be faster and easier and there should be tools for gamblers to limit reverse withdrawals. Periods of winning may represent important, and underutilised opportunities for staff intervention. The report also suggests responsible gambling tools to interrupt long sessions of fast, continuous betting online.

The study analysed data from an internet gambling operator capturing several thousand betting transactions of 101 problem gamblers (as defined by customer responses to the Problem Gambling Severity Index). The researchers analysed the sequences of gambling behaviours for individual problem gamblers, to identify patterns of potentially harmful gambling behaviour and propose explanatory mechanisms and risk factors that could account for such play. In-depth interviews with problem gamblers helped the researchers interpret the behaviour they observed in the data. In this way, the study aimed to generate new ideas and insights, which can be verified with further research.

This project was commissioned by GambleAware as part of its programme of research to improve understanding of the nature and risks of remote gambling and to examine how such risks and associated harms can be mitigated.

## Clare Wyllie, Director of Research & Evaluation at GambleAware said:

"Online gambling is the most rapidly growing sector. This research shows how going online can change the characteristics of gambling and create new risks. It also highlights how important it is that online operators make sure the features they provide encourage safe rather than risky play."
