> "There's not a lad in here who doesn't gamble. It's all some lads in here live for. You don't want to get in debt in here though, it's just not worth it ... I see lads slashed up every week because of gambling" 2

The overall aim of the programme is to develop evidenced approaches to reduce the impact of gambling-related harm amongst those within the criminal justice system in Great Britain.





Aims

- Raise awareness of the issue
- Provide Command/GambleAware with an understanding of prevalence
- Help military personnel to understand their patterns, the dangers and practical tools to self help
- Establish intervention pathways
- Move gambling from entertainment to health
- Initiate debate on provision of betting machines inside the wire
- Assist integration of support agencies such as Debt and Welfare

How

- High Level Support multiple entry points
- Sub-unit buy in
- Educate and evaluate (OMBEA and Aide Memoir)
- Access
- Health issue
- Queen's Regs
- Machines inside the wire
- Utilise existing intervention pathways, Medical, Welfare, Discipline, possible partnership with Gamcare
