Introduction

GambleAware is commissioning a scoping paper that will establish what is known about stigma related to gambling and gambling harms. Knowledge about stigma, and the discrimination it drives, will inform all GambleAware's commissioning activity to prevent gambling harms, including public awareness campaigns, education, treatment, and research.

Stigma is the "situation of the individual who is disqualified from full social acceptance"¹, and stigma drives discrimination and social exclusion of stigmatised communities. Stigma is a considerable barrier to accessing service and healthcare provision for stigmatised communities: research commissioned by GambleAware has demonstrated stigma is a barrier for one in ten to seek help for gambling harms.²

An understanding of stigma related to gambling and gambling harms therefore is necessary to address these barriers to treatment and support, including to services commissioned by GambleAware. This research will be the first step towards a programme of work that builds knowledge in this nascent area of stigma associated with gambling and gambling harm. GambleAware is conscious that there is a wealth of knowledge about stigma which has been applied and explored in other contexts; however, research into the relationship between stigma and gambling is as yet underdeveloped. GambleAware is therefore keen to learn from other sectors and disciplines: the successful applicant will have expertise and knowledge of stigma, stigmatisation, and social exclusion, but will not necessarily have specific knowledge of gambling.

The research project will commence after the signing of the grant agreement, and the budget envelope is £20,000 including VAT over a maximum of 4 months.

Existing Research Focussing on Stigma

Existing research³⁴⁵ focussing on stigma related to gambling and gambling harms takes two broad approaches:⁶

1) Research establishes extent of stigma of gambling and gambling harms, and compares this stigma to other forms of stigma, such as the stigma of disorders, identities, and activities.

2) Research investigates stigma as a barrier to accessing service and healthcare provision for gambling harms.

However, it is argued that our taken-for-granted understandings about gambling and gambling harm may *themselves* be stigmatising. Despite this, research – internationally and in Great Britain – has not focussed on addressing this. There is therefore a need for research on stigma related to gambling and gambling harm to be expanded to include a critical analysis of common and accepted understandings and social constructions.

Purpose and Aims

This scoping paper will be a narrative literature review. It will establish what is known about stigma related to gambling and gambling harms, and areas where further research and understanding are necessary.

In drawing on the literature, the paper will aim to establish:

- 1. The nature of stigma of gambling and gambling harm: how it comes about and how it compares to other forms of stigma.
- 2. How stigma serves as a barrier to accessing support, service and healthcare provision, and support in the community and from peers.
- 3. A critical analysis of current research and understandings, establishing how existing understandings of gambling and gambling harm reproduce stigma.

Expected Output

A paper that is:

- Written for lay audience with policy and/or service and healthcare provision interest.
- 6,000 9,000 words in length.
- Written in accordance with GambleAware's <u>Research Guidelines</u>.

Process for appointment
